A Special Meeting of the Board of School Directors of the Hanover Area School District was held on Thursday, August 25, at 6:00 PM. The meeting was called to order by the Board Vice President, Dr. Vic Kopko.

Dr. Vic Kopko, Board Vice President, provided the following Executive Session Report: "Prior to the Public Meeting, the Board met in Executive Session to discuss Personnel matters. Member of the public, is there any input on agenda items only?"

Mike Potsko, Hanover Township addressed the board. He asked about public notices for meetings and noted that this meeting was not on the district website. He asked if the district posted notices in certain newspapers and if, so, which ones. Mr. Barrett replied that we posted the notice for this special meeting 24 hours ahead of time on the district webpage along with the agenda. Mrs. Kitchen replied that the district posts its notices in the Citizen's Voice newspaper in addition to the district webpage. Mr. Potsko then asked about the 4 police officers who were listed on the agenda to be hired this evening. He raised a concern that there are five buildings in the district, but there are only 4 officers to be hired. Mr. Barrett responded that the district is still in an active contract with the Township for the SRO program, so the SRO would remain assigned to the high school building for this school year.
